TPP Issues to be debated

Talks continue on the Trans Pacific Partnership with the 6th round having been completed in Singapore in March. Further rounds take place in June, Sept and October prior to the US hosting APEC in Hawaii in November. We believe that good progress has been made in several areas however at the recently held US NZ Partnership Forum, NZ stance on IP came under the spotlight so this year's forum we are looking to fully air the issues around the TPP talks, with an aim of flesh out the issues and allow them to be debated.

Innovative companies trading with the USA invited to enter awards

Companies trading with the United States are invited to enter the 2011 **American Chamber of Commerce – DHL Express Success & Innovation Awards**, held in conjunction with **Qantas Airways**. Over the last eleven years prizes valued at more than \$300,000 have been collected by winners.

Two-way trade between New Zealand and the USA is currently running at more than \$8 billion, which accounts for approximately 10% per cent of New Zealand's total earnings from overseas trade.

AmCham's Executive Director, Mike Hearn, said the Chamber constantly sought opportunities to enhance and expand business and trade relationships within the private and public sectors.

"The annual Success & Innovation Awards provide an opportunity to showcase those companies that have demonstrated imagination, innovation and entrepreneurship, as well as honour and celebrate their achievements."

Investor of the Year for New Zealand companies investing in the US, as well as US companies investing in New Zealand

U.S. Chamber's International Agenda

For several months now, Washington's trade agenda has been enjoying a slow thaw, but springtime has now arrived in full force -- cherry blossoms and all. President Obama, Congressional leaders of both parties, and the business community are now all working toward the common goal of securing approval of the pending trade accords with South Korea, Panama, and Colombia within a few weeks, alongside renewal of Trade Adjustment Assistance and the lapsed Generalized System of Preferences and Andean Trade Preference programs.

It's a remarkable turnaround. Most recently, the United States reached an agreement with Colombia on labor and judicial reforms that will open the door for Congressional approval of the long-pending U.S.-Colombia Trade Promotion Agreement.

The Chamber applauded. "Presidents Obama and Santos showed courage and pragmatism in striking this accord," said Chamber President Tom Donohue. "Passionate, bipartisan support in Congress for the trade agreement with Colombia was also critical to this breakthrough, as was the tireless work of Ambassador Kirk. This proves the United States can still lead on trade."

Also, on April 13, Panamanian lawmakers approved a tax information exchange agreement (TIEA) with the United States, and President Ricardo Martinelli is expected to sign it this week. Approval of the TIEA is the last item U.S. officials have indicated should precede consideration in the U.S. Congress of the U.S.-Panama trade agreement.

These are budget-neutral, job-creating agreements will create billions of dollars in new exports within a few short years. They will create a level playing field for American workers and farmers by eliminating the barriers that stifle trade. [Read the Full Text Here](#)

New Zealand, Champions of the World again!

After a year of hard work New Zealand has done it again with one of the Kiwibot teams winning, not only the World VEX College Championships but also the Supreme Excellence Award as well. Team MESS1 from Massey University's Engineering Societies Albany campus were crowned VEX college Champions for 2011. MESS1 showed the rest of the world their true colours and strode to victory after three days of intense competition against 34 other University robotics teams from around the world. Their victory was not without its nail biting moments as opposing teams sometimes forgot the creed of fair play and used their robots as battering rams in an attempt to slow MESS1 down. The strength and overpowering capabilities of Massey University's robots meant that these tactics were fruitless and in one case led to the offending robot being disqualified. The Excellence Award went to both teams from Massey University in recognition of not only their unrivalled performance at the competition but their dedication to the robotics competition in New Zealand in helping and mentoring High School teams.

Such was the strength of the University teams from New Zealand that they managed to secure the first three places in the qualification rounds of the event with team MESS1 leading the charge followed by team AURA (Auckland University Robotics Association) and backed up my team MESS2. The timer and hard work put into preparing for the competition combined with the superb mentoring they offered to High Schools certainly showed in the final results.

Team AURA (Auckland University Robotics Association) were awarded the second highest award of the competition, the Judges Award, in order to recognize their achievements that covered many aspects of the competition.

The New Zealand defending High School Champions, team 2921 - Free Range Robotics, managed to win their division champions title again this year but were knocked out in the last round of the World Championship by an alliance of robots that managed to find the one weak spot in Free Range Robotics armour. They were awarded the Think Award for a team with impressive and effective autonomous programming. This award was truly deserved and it was an honour to watch their robot scoring with no human interaction whatsoever. It was difficult to tell when the driver control part of the competition started, after the autonomous part.

Lynfield College, team 2915, not only succeeded in making it to their division's finals but they won the Create Award for a Robot with a creative overall engineering solution. Their design stood out from the crowd with its tube collection mechanism and proved to be a hit with teams wanting to see something different.

Rangitoto College, team 2901, cemented last year's victory in the Autodesk Inventor CAD (Computer Aided Design) Competition by winning the title again this year. This proves that New Zealand has the formula right and that the support teams are receiving the training they need from our industry partners.

Hundreds attend Washington D.C. ANZAC Day Dawn Service

Korean War Veterans' memorial Around 450 people attended an Anzac Day dawn service at the Korean War Veterans' memorial in Washington D.C on Monday 25 April EST.

In his address at the dawn service, New Zealand Ambassador Mike Moore spoke of the "mateship" that existed between Australia and New Zealand service men and women.

"This bond is getting stronger, not weaker," he said.

The Ambassador also spoke of the need to remember not only the ANZACs of the past but those that served the country today.

"There is much to admire about the younger generation. They too, remember".

As with Anzac Day services around the world, the number of people who attend dawn service in Washington DC continues to increase.

Wreaths this year were laid by the governments of the United States, Turkey, Korea, the United Kingdom, Canada, and France, as well as by a number of expat organisations including New Zealand's KEA (Kiwi Expatriates Abroad) Association.

U.S. Memorial Day Service at Auckland War Memorial Museum

The United States Veterans Club of New Zealand will hold its annual U.S. Memorial Day Service at Auckland War Memorial Museum's Hall of Memories on Sunday, May 29 2011, at 2 p.m. The club has laid wreaths at the Auckland War Memorial Museum every year since 1948, and this year's commemoration will mark the 63rd anniversary of the first U.S. Memorial Day service in Auckland.

But in particular, if there are veterans of U.S. military service in the region, Veterans' Club President Mike Riley would like them to come along – and to join the club, to help ensure this important link between the U.S. and New Zealand continues to be commemorated.

Qantas commences its Sydney to Dallas Fort Worth (DFW) non-stop service on 16 May. The four-times weekly service replaces the airline's Sydney – San Francisco service, and places travellers right into its' OneWorld partner American Airlines' Texan hub, allowing excellent connections to the East Coast (including all 3 New York area airports and the Caribbean). Travel on various dates throughout much of this year. We are offering as much as 30% off economy class and 25% off premium Economy fares to the US on Air New Zealand services. Business travellers can also save around \$1000 per trip for their company when flying **Qantas** or **Air New Zealand** business class to the US. Both airlines have introduced the 21-day advance purchase airfare on an ongoing basis. Business travel cover gets an upgrade

Business travel insurance is changing. In 2011, corporate travellers are scoring coverage which could see their benefits substantially increase.

Smart companies are catching on to the changes within business travel insurance to access protection against a broader range of risks. The days of a simple policy covering personal accident and sickness expenses, cancellations and theft are long gone. A policy being relaunched by ACE Insurance Limited (ACE) illustrates the point. It is a policy which is designed to benefit the insured company, its employees and their families. It provides flexible coverage options to suit business needs and includes upgrades from previous ACE policies.

Search and Rescue Expenses are a good example of a new coverage available. In its updated policy, ACE provides financial protection if an insured person is reported missing and it becomes necessary for a rescue provider or police authorities to instigate a search and rescue operation. ACE would reimburse the policyholder up to \$20,000 per insured person, up to a maximum of \$100,000, in respect of certain costs incurred by a recognised rescue provider or the police authorities.

Matt Bouzaid, ACE NZ Accident & Health Manager, said: "We've updated our cover in response to requests from brokers and clients, and after consultation with the ACE Claims team. New covers have been developed and existing covers enhanced to meet evolving needs. For business travel insurance policies bound or renewed after 1 June 2011, we are pleased to extend our policy in a number of areas, such as covering the costs associated with search and rescue operations."

Another new feature relates to coverage for the cancellation or curtailment of travel due to the unexpected death or serious sickness or injury of an insured person's close relative, business associate or travelling companion. Some policies may exclude this coverage if the death or sickness is a result of a pre-existing medical condition. However, if the event is unexpected the ACE Business Travel Insurance policy will cover the cancellation or curtailment expenses in this situation.

"When tragedy falls upon a loved one, or when your colleague is struck down with an illness, we believe it is critical that as your insurer we respond. Having the confidence that cancellation expenses are covered takes one less stress away from what can be a highly distressing situation," said Bouzaid.

Lockheed Martin Engages Local Businesses at New Zealand Industry Day

Industry Capability Network (ICN) and the Investment Team of New Zealand Trade and Enterprise arranged the 'Lockheed Martin Engagement with Industry Day' on 9 March. This was a major initiative with a US multi-national looking for new technology and products for their programmes and global supply chains. Around 80 people from over 50 New Zealand companies attended the briefing, which was lead by Marilyn Hewson (Executive Vice President of Lockheed Martin Electronic Systems) and her team of senior executives.

The briefing was followed by 63 'speed-dating' type meetings where the New Zealand companies had a 15 minute opportunity promote their product or service one-on-one to the Lockheed Martin Staff.

Business NZ in conjunction with Lockheed Martin held a reception for business leaders and government officials on the evening of 9 March, which Minister Groser also attended. Minister Groser commended NZTE on the initiative and noted helping get NZ companies in the global supply chains of major global corporations was an initiative he fully supported.

US Government invests in New Zealand green energy technology

The United States Department of Energy (DOE) has, through North West Energy Innovations based in Oregon, invested US\$2m in a wave energy project using technology developed by IRL in New Zealand.

Wave Energy Technology NZ (WET-NZ), a collaboration between IRL (83.8%) and Power Projects Ltd (16.2%) and supported by the Ministry of Science and Innovation and EECA, has over the past three years proved the operating concept by trialling a one-fifth size wave electrical generation device anchored off Taylor's Mistake in Christchurch. The device was recently upgraded to a quarter-size machine and operated successfully for 90 days, generating electricity with no down time.

The technology is different from other wave energy converters in that the machine is anchored to the sea floor and recognises water movement, which through the use of on-board hydraulics, converts water energy into electricity, says IRL Deputy CEO Drew Stein.

"We are working directly and closely with North West Energy Innovations in Portland and the DOE as this project progresses. Our research program involves building a half-size device which is being manufactured by Stark Brothers in Christchurch."

This machine, when completed in June and after testing off Akaroa, will be relocated and anchored to the sea floor off Moa Point in Wellington. IRL will ship another set of control and hydraulic components to the USA where they will be installed in a half-size device built to IRL's design, which will be anchored to the sea bed off the Oregon coast, he says.

"We anticipate that once these devices have proven themselves under the strict USA Department of Energy review processes then licences for the wave energy converter will be signed. Future sales are predicted to be worth hundreds of millions of dollars to the New Zealand economy.

"The wave energy converter technology is protected by international patent applications including an application in the United States. A patent has already been granted in New Zealand and IRL is anticipating all design, control and hydraulic components will be manufactured by New Zealand companies and exported around the world.

"Demand for clean, green energy has never been more economically important nor in more demand and therefore there is a ready-made market for this type of electricity generating device," says Drew Stein.



TAXATION MATTERS

United States Federal tax update

New reporting requirements were recently introduced for United States persons holding foreign financial assets exceeding US\$50,000 in the aggregate.

Form 8938 is required to be attached to the income tax return being filed for taxable years beginning on or after January 1, 2011.

Failure to file will result in a penalty upwards of US\$10,000 and potentially as much as US\$50,000 for repeated breaches of this reporting requirement after IRS notification of a breach.

It should not be long before the new Treasury regulations covering the future obligations of foreign financial institutions (FFIs) are released. Significant lead time is required to enable FFIs to prepare for the new requirements affecting them from 2013 and it is expected that the regulations will be introduced in 2011 and 2012.

Late April 2011 the IRS also announced that enforcement of the new return preparer rules has commenced, with the initial focus being on preparers with criminal convictions.

A comparison of Preparer Tax Identification Numbers (PTIN)s against a database held by the IRS' Office of Professional Responsibility identified 19 preparers either whom have criminal convictions that they failed to disclose upon applying for a PTIN, or whom had already been permanently enjoined from preparing returns. Those preparers have twenty days to respond with documentary evidence as to why they shouldn't have their PTIN revoked.

Also under the spotlight are returns received that have irregular preparer details. Such irregularities being checked include incomplete preparer information, for example, the absence of a PTIN or preparer signature, and/or numbers other than PTINs being furnished.

The new return preparer rules apply to any person who receives compensation for preparing all, or substantially all, of a United States tax return or disclosure. Penalties for non-compliance start at US\$50 per offence, including for such offences as failure by the preparer to sign a return he/she prepared, and are capped at US\$25,000 per annum.

Also announced in April 2011 is that the IRS and the Treasury Department are inviting taxpayers' recommendations for possible incorporation in to the Guidance Priority List. This is a list published annually by the United States' government covering issues that the IRS plans to address in an annual process, the next period being July 1, 2011 to June 30, 2012.

Comments are required to be submitted by 1 June 2011.
